## **Special Meeting**

#### Call to Order

Vice President Medrano-Sanchez called the Special Meeting to order at 7:05 pm.

#### **Remote Attendance**

President Taylor requested to attend the meeting virtually under 5 ILCS 120/7(a) due to illness. Trustee Becker made a motion to allow remote attendance and Secretary Sharkey seconded. The motion passed by roll call vote:
