ORDINANCE NO. 2024-2025-103

**LEVYING TAXES FOR THE FISCAL YEAR BEGINNING
JULY 1, 2024, AND ENDING JUNE 30, 2025**

WHEREAS, applicable statutes authorize the Board of Trustees to levy taxes for library purposes,
NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Algonquin Area Public Library
District, McHenry and Kane Counties, Illinois, as follows:

Section 1: Ordinance No. 2024-2025-101 (Budget and Appropriation Ordinance) previously
passed by the Board is incorporated by reference.

Section 2: A tax in the sum of \$7,137,075.00 is levied upon all taxable property within the
District, said tax levied to defray expenses and liabilities of the District for the fiscal year beginning
July 1, 2024 ending June 30, 2025 for the specific objects and purposes indicated as follows:


